Carol E. Zacharias, 73, Topeka, passed away Sunday, December 3, 2006. Carol was born in Pittsburgh PA on April 22, 1933, the daughter of Archibald Robert and Mary Catherine (English) Kennedy. She grew up in Winfield KS. Carol graduated from the College of St. Teresa College in KC MO in 1953. Carol worked as a Registered Nurse at St. Joseph Hospital in KC MO. She married David Zacharias, M.D. in 1955. While raising their four children in KC, MO and later in Topeka KS, Carol was an active community volunteer. In Topeka she served as volunteer for Mulvane Art Center Women's Board, ERC, and Historic Topeka. Her love for cooking led to feature articles in newspapers and magazines. She was a member of Most Pure Heart of Mary Catholic Church.
